## Intent to Apply for the 2023-2024 ESSA Federal Grant Funding

**Title II, Part A, Preparing, Training, and Recruiting High-Quality Teachers, Principals, or Other School Leaders** - Intent and Purpose: Title II, Part A, provides resources to LEAs for the following: to increase student achievement on state academic standards, to improve the quality and effectiveness of teachers, principals, and other school leaders, to increase the number of teachers, principals and other school leaders, to provide low-income and minority students greater access to educators

#### Award Amount: \$16,081

Allowable Uses Include:

- Redirect 100% of these funds for use on Title I, Part A campuses.
- Redirect 100% of these funds for Title IV, Part A purposes.
- Professional development supplies and materials
- Staff salaries (professional, certified and paraprofessional)
- Professional and contracted services
- Professional development for staff and parents/guardians

**Title IV, Part A, Student Support and Academic Enrichment** - Intent and Purpose: To improve the academic achievement of all students by increasing the capacity of LEAs, schools, and communities to provide all students with access to a well-rounded education, to improve school conditions for student learning, and to improve the use of technology in order to enhance academic outcomes and digital literacy of students

#### Award Amount: \$10,602

Allowable Uses:

- Redirect 100% of these funds for use on Title I, Part A campuses.
- Redirect 100% of these funds for Title II, Part A purposes.
- Instructional supplies and material
- Professional development in technology and contracted services

• Technology infrastructure (limitation – 15%)
