# V. Review and approve the minutes from the January 26, 2023 meeting

# VI. Review Healthy Families Night

The event had a good turnout with 117 elementary students and their families attending. Ten vendors participated, from the Santo Clinic to the Children's Alliance. Every student went home with a jump rope, a healthy side-dish kit, a water bottle, a fruit cup, and many went home with bicycle helmets or lifejackets.

VII. Discuss Board approval of Policy FFA(LOCAL) and SISD Local Wellness Implementation Plan at the March 20, 2023 School Board meeting

The Santo ISD School Board approved both the local wellness policy and the implementation plan at their regular March meeting with only one recommended change—the removal of the

Food/Nutrition Marketing language from both documents. SHAC members agreed with the recommended changes.

VIII. Discussion and possible action on SHAC recommendations to the Elementary and Secondary Campus Improvement Plans for 2023-2024 in the areas under their scope as detailed in FFA(LOCAL)

The current Elementary and Secondary Campus Improvement Plans (CIP) were shared with SHAC and suggestions or recommendations are as follows:

Elementary CIP:

- Be sure Jump Rope for Heart is listed as a an activity on Page 12 with PE, laps during lunch, etc
- Check to see if Heart Heroes is a program Elementary wants to implement

Secondary CIP

- There needs to be more separation in the CIP between programs tailored for JH students and HS students
- Some of the programs listed have not been presented this year, possibly due to a change in counselors mid-year

#### IX. Review existing procedures and discuss additional ways to prevent bullying

Representatives from both campuses discussed bullying prevention measures/procedures on their respective campuses, including the anonymous reporting app on the website, Social/Emotion Learning (SEL) lessons on bullying, kindness, conflict resolution, internet safety and cyberbullying being taught at both campuses.

Stacy Finley recommended the committee research ways to engage 6<sup>th</sup> graders transitioning to the secondary campus.
